This risk assessment should be used in conjunction with the current Government guidance regarding Covid 19 mitigation measures. The Government maintains and regularly updates a range of documents giving guidance on managing the impact of Covid-19. The documents are updated regularly in accordance with government announcements and these should be checked regularly with the information on this risk assessment updated accordingly. You should always refer to the most up to date documents maintained on www.gov.uk.

This risk assessment should be made available to anyone using or maintaining the pavilion building. A current copy of this risk assessment should be displayed on the notice board in the pavilion.

In order to minimise the risks of Covid-19 the hygiene requirements set out by the Government and included below must be adhered to. If this is not possible the pavilion should not be used.

## **Reporting and Tracking**

At the time of writing the only groups with permission to use the pavilion are Manea United, Manea Strikers and Manea Sirens Football Clubs. The football clubs must adhere to the record keeping guidelines issued by the FA. Through this process any users of the pavilion (including family spectators) can be contacted in the event of a positive Covid-19 test. A list should be made available in the pavilion so that spectators not covered by the FA process can leave their details and be contacted in the event of a positive Covid-19 test. It will be the responsibility of whichever club is using the pavilion at the time to make this list available. It has been agreed that the football clubs will notify each other should a positive Covid-19 test be returned by someone who has attended the pavilion.

The Parish Council must immediately be notified by the football clubs nominated contact following a positive Covid-19. The pavilion will be immediately closed until further notice. Council staff and members will immediately be made aware of the situation so anyone affected can follow the government guidelines and be tested if necessary.
